General Notice

The Certified Ethical Hacker (CEH) certification will fortify the application knowledge of security officers, auditors, security professionals, site administrators, and anyone who is concerned about the integrity of the network infrastructure. The Ethical Hacking and Countermeasures course mission is to educate, introduce and demonstrate hacking tools for penetration testing purposes only. You will not use your newly acquired skills for illegal or malicious attacks or in an attempt to compromise any computer system, and to indemnify EC-Council and its partners with respect to the use or misuse of these tools, regardless of intent.

The hacking tools are not authored by EC-Council, and in many cases these tools are submitted by the security community.
